#### ANTIGEN DISTRIBUTION AND SPECIFICITY:

The human CD50 antigen is the third receptor for LFA-1 and is a 110 kDa N-glycosylated monomer. The CD50 antigen molecule is a focal point for leucocyte interactions and involved in signal transduction across the plasma membrane. Also designated InterCellular Adhesion Molecule (ICAM-3), it is phosphorylated during T-cell activation. CD50 is found on a wide distribution of leukocytes

#### CONJUGATION:

Fluorescein isothiocyanate; R-Phycoerythrin.

#### HANDLING AND STORAGE:

All forms are supplied as  $1.0~\mathrm{mL}$  of liquid, or  $0.5~\mathrm{mL}$  for 50-test size. Fluorochromes should be protected from prolonged exposure to light. Reagents will be in a medium containing  $0.01\mathrm{M}$  phosphate-buffered saline, pH 7.4, 0.2% gelatin and 0.1% sodium azide. These preparations should be diluted in a protein-containing or other stabilizing medium to a concentration suitable for use in specific protocols. All reagents in a liquid state should be stored at 2-8° C when not in use.

## PRODUCT USE:

Use 10 uL per test to stain no more than one million cells.; For immuno-histochemistry, purified Anti-ICAM-3 should be diluted, using enough reagent to cover the tissue section or cytoprep.

#### RESEARCH APPLICATIONS:

Studies of signal transduction.

Studies of serum free CD50 in Systemic Lupus Erythematosus (SLE).

Studies of cell adhesion involving LFA-1 (CD11/CD18 complex).

Flow cytometric analysis of CD50 distribution.
